## Limited Warranty

All United Window & Glass guarantees that all **Vinyl and Aluminum Windows** manufactured and/or distributed will be warranted for a period of five years from the original date of purchase. Warranty coverage insures that materials purchased will not peel, corrode, rot, warp, blister or flake. The warranty does not cover damage caused by (1) improper handling and use; (2) damage at the time of installation; (3) improper operation; (4) negligent lubrication; (5) acts of nature; (6) application of corrosive cleaners or cleaning techniques; or (7) vandalism.

All United Window Glass guarantees that all **Insulated Glass Units** produced will be warranted for a period of one year from the original date of purchase. Warranty coverage insures that units will maintain free of visual blemishes such as dust, film and condensation build up on the internal glass surface as a result of failure of the hermetic seal resulting from faulty manufacturing. The warranty does not cover damage caused by (1) improper handling and use by customer; (2) damage at the time of installation; (3) accidental breakage by contractor/homeowner; (4) seal tampering; (5) acts of nature; or (6) vandalism. Rainbows and prisms are properties of insulated glass units and are not recognized as a product defect. Condensation appearing on the exterior surface of the window glass is due to interior/exterior temperature & humidity levels and does not indicate faulty manufacturing or installation.

All United Window & Glass guarantees that all **Window Hardware** will be warranted for a period of one year from the original date of purchase. Warranty covers hardware used under normal conditions. Warranty does not cover damage caused by (1) improper installation, (2) improper use or use for purposes other than it is designed; (3) damage caused by debris or dirt accumulation; (4) neglectful maintenance; or (5) vandalism.

This warranty shall apply only to the original purchaser and not the subsequent user/owner. This warranty shall not apply to any window(s) subject to accident, acts of nature, fire, flood, abuse, neglect and misuse. **This guarantee covers replacement material only.** All United Window & Glass will not assume any expense with the removal or reinstallation of any replacement parts or windows. Under no circumstance will All United Window & Glass be held liable for indirect, consequential or incidental damages including, but not limited to damage or loss of other property or equipment. All United Window & Glass will not be held liable for any accidental injury or damages resulting from improper installation, handling and operation of products. **This warranty covers original material only. No item(s) altered or replaced by the owner will be covered. Damage caused by maintenance, attempts to fix and/or tampering by the owner or other party will not be covered.**
